The referee must include their contact information and title/role that they hold with the organization. *Cannot be a Folklorama Board or Operations team member.*

- To be considered for the Board of Directors slate, Nominees must be interviewed by the Nominating Committee. Interviews will be scheduled from January 17 – 26, 2023. Exact date and time will be confirmed with the applicant prior to scheduling the interview.
- The Board Information Session will be hosted by the Nominating Committee on Monday, November 21, 2022, from 7:00 – 8:00pm at the Folklorama offices. **All are welcome to attend.**
